## Changes to our Section's Constitution and Bylaws

Last year, the Nebraska Section began the process of updating our Section's Constitution and Bylaws. A committee was formed to research the governing documents of other Sections and Branches, propose changes to the existing Board, modify them according to the Board's comments, and shepherd the proposed changes through the approval process. Tom Marnik, Ed Prost, Tom Strauss, and Marie Maly were members of the committee. The proposed changes included in the newsletter this month represent months of work and coordination. ASCE's legal staff reviewed the changes, and we were notified on September 20, 2007, that the Committee on Geographic Units had approved them. Please review the documents and consider your opinion – the ballots for the ratification of proposed Constitutional changes will be included in both the October and November newsletters. Please see the ballot for full details on how to return your vote. The Subscribing Members present at our November Section meeting will vote on the Bylaws amendments. 
